I **FULLY ACCEPT AND ASSUME ALL RISKS AND RESPONSIBILITY FOR ANY INJURY I MAY INCUR OR CAUSE TO OCCUR TO OTHERS** as a result of my failure to take caution including while operating a vehicle after participating in the event/activity.

I acknowledge that this event/activity may involve a test of a person's physical and mental limits and carries with it the potential for death, serious injury, and property loss. The risks include, but are not limited to, those caused by terrain, animals, facilities, temperature, weather, condition of participants, equipment, vehicular traffic, lack of hydration, and actions of other people including, but not limited to, participants, volunteers, monitors, and/or producers of the event/activity. These risks are not only inherent to participants, but are also present for volunteers. I hereby consent to receive medical treatment which may be deemed advisable in the event of injury, accident, and/or illness during this activity.

I understand while participating in this event/activity, I may be photographed. I agree to allow my photo, video, or film likeness to be used for any legitimate purpose by the event/activity holders, producers, sponsors, organizers, and assigns.
